Assignment Task:

THE SCENARIO:

You are still working as a Law Clerk with Bridget at her law firm, Flinders Legal.

Bridget has been impressed by the work you did for her on Barbara's file and asks you for help on another matter. This time it concerns Barbara's son Gennaro Napolitano. Barbara mentioned it when she last met with Bridget. Bridget has opened a new file for this matter.

Barbara is an important client for the firm so Bridget is very keen to do a good job for her.

She has left another memo for you on your desk.

THE TASK:

Your task is to do what Bridget has requested in the attached memo.

The memo asks you to include a report that reflects on the research path/process you undertook to locate the primary and secondary sources that you have used in your memo.

For the purposes of this assignment, such a report must contain the following points as a minimum:

- ✓ It must be is sufficiently detailed to allow the reader to repeat the research path undertaken.
- ✓ It must contain an actual self-reflection on your research path. This involves considering and reflecting on matters such as:
 - ✓ what worked/didn't work and why;
 - ✓ what was easy/difficult: and
 - ✓ what tips/traps/techniques etc to remember for next time.

The workbook used in the Library Skills Workshops for this topic contains sections that were designed to get you thinking about this issue during your research exercises. Use them as a guide for this aspect of the assignment.

RE: New File 125/2012 –/Admission to practise law: Barbara's son, Gennaro

At my last meeting with Barbara, she told me that her son Gennaro has recently finished his double degree in Engineering/Law and Legal Practice at the University of Norwood.¹ He is

preparing the documents he needs to submit for admission to practise law in South Australia.

Barbara is very concerned because during Gennaro's first year at University when he was studying *ENGG1101 Engineering Physics and Materials* he got caught out for a breach of academic integrity. Although Gennaro went on to complete his studies successfully, Barbara feels that this "might mean trouble for him if the Law Society finds out."

I have a feeling that Gennaro has a duty to disclose this to the Supreme Court in his application documents, but I need to know whether I am right. I attended a professional development seminar on this. The presenter mentioned a couple of Australia cases. There is a Queensland case *Re Liveri* [2006] QCA 152. There is also a Tasmanian case called *Richardson* (or some name like that) and there is a Victorian Supreme Court case with an odd-sounding name that I can't remember. There may be others. There will also be some key South Australian legislation on this topic.

Undoubtedly, there will be **secondary sources** on the topic.

I need you to prepare:

- 1. A memo telling me what are the requirements of disclosure for admission to practise law in South Australia:
- 2. a report that reflects on the research path/process you undertook to locate the primary and secondary sources that you have used in your memo.

Once you have done that, we will interview Barbara and Gennaro to get the relevant facts. We will then decide how to provide them with the legal advice they need.

I need the memo by **18 May at 4pm.** Try to present and structure it so that it is as readable as possible and so that I can quickly understand what you are communicating. Take into account the feedback you received about your last memo.
